Provider Reimbursement Rates

Background

In accordance with WD Letter 12-18, policy number S0208 Provider Reimbursement Rates has been amended to reflect the increased child care provider reimbursement for all nonrelative provider effective August 1, 2018.

Policy

On February 9, 2018, the Bipartisan Budget Act of 2018 was enacted. The Act included a historic funding increase for the Child Care and Development Block Grant. The new rates are designed to reflect the higher costs of high-quality care and to incentivize more providers to participate in the TRS program. The Commission specifically required the following rate increases for nonrelative child care providers:

- Increase rates for all non-TRS/non-Texas School Ready! (TSR!) providers by 2 percent.
- Set reimbursement rates for TRS 4-star providers at the 75th percentile of the 2017 local market rate.
- Set reimbursement rates for TRS 3-star providers at 90 percent of the local 4- star rate.
- Set reimbursement rates for TRS 2-star providers at 90 percent of the local 3- star rate.

Additionally, enhanced for TRS-certified providers must continue to follow the requirements set forth in Texas Government Code §2308.315 and reflected in TWC Child Care Services rules at §809.20(b)–(c). The minimum reimbursement rate for a TRS-certified provider must be greater than the maximum rate established for a provider that is not a TRS-certified provider for the same category of care. The reimbursement rate must be:

- at least 5 percent higher for a provider with a 2-star rating;
- at least 7 percent higher for a provider with a 3-star rating; and
- at least 9 percent higher for a provider with a 4-star rating.

Pursuant to §809.20(d), rates established at higher percentages than the percentages listed above must have at least a two percentage-point difference between each star level. Finally, §809.20(c) requires that rates for preschool-age children at a TSR!-certified provider must be at least 5 percent higher than the Board's non-TRS rate.
